The alternative route is shown by a black dashed line on the Order map and will extend from the point marked. A on the Order map at grid reference easting 443019 northing 302581 in a generally north westerly south westerly and south easterly direction for a total distance of approximately five hundred and thirty six (536) metres to the point marked C on the order map at grid reference easting 442695 northing 302342.
